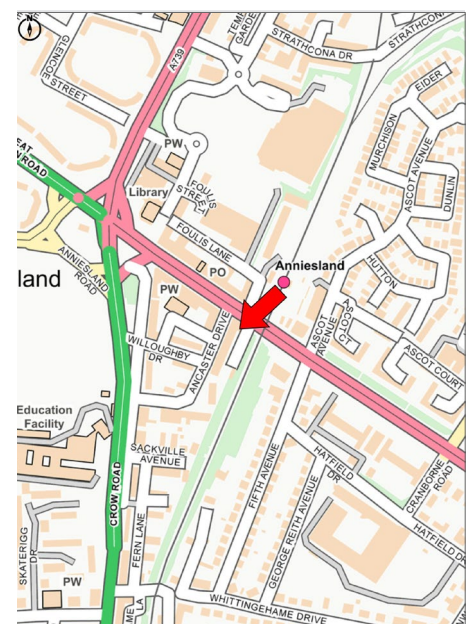

LOCATION

The subjects are located on Great Western Road in an established retail parade that lies in close proximity to Anniesland Cross, within the Anniesland area of Glasgow. The area is characterised by a mix of residential and commercial properties with notable surrounding occupiers such as Greggs, Boots and TSB. Great Western Road is an arterial route leading into the city centre and a number of public transport links, including Anniesland railway station are immediately accessible.

DESCRIPTION

The subjects comprise a ground floor retail unit within a three storey traditional tenement building. The property benefits from open plan accommodation with large display windows. There is ancillary storage located at the rear of the property in addition to toilet facilities. The property would suit a variety of retail uses.
