The pilot process was undertaken with permission from the local authorities Environmental Health Officer and exclusively utilized a process known as RUDERAL.

In addition, an associate company of Embergreen Exeter Limited also benefits from a Waste Management Licence permitting the operation of the Hill Barton Business Park site as a waste transfer station facility.

Method of Sale

The leasehold interest in the property at unit 8 Hill Barton Business Park is for sale as a whole by private treaty.

Tenure

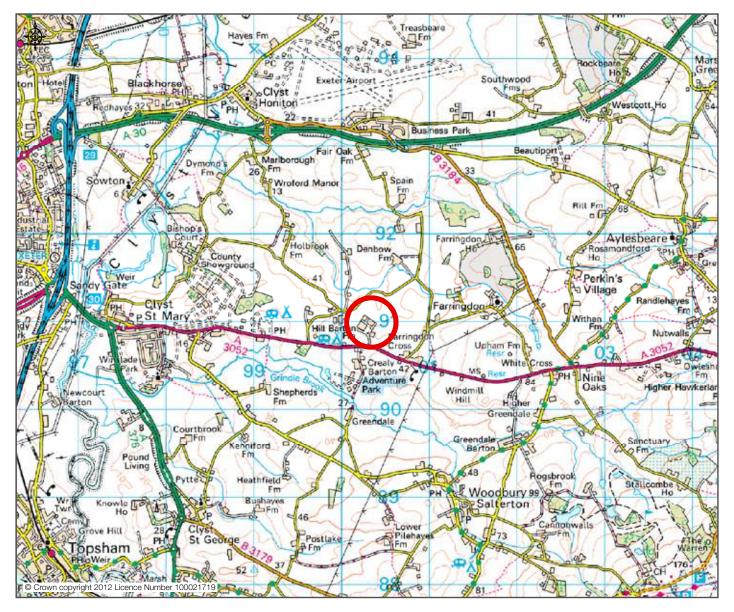
