Location

The premises is situated on Cumberland Avenue which provides easy access to the A406 North Circular road and the A40. The A40 provides direct access to Central London to the East and the M40 and M25 motorway networks to the West. Within half a mile lies Park Royal Underground Station (Piccadilly Line) providing excellent access into Central London and the surrounding areas.

A modern steel portal framed industrial / warehouse unit benefiting from a securely gated yard ideal for loading and parking. Access to the warehouse is via a full height electric roller shutter loading door benefiting from an excellent clear eaves height of 7.5m, 3 phase power and a gas supply.
