

The entrance lobby with passenger lift is accessed from Mare Street, with secondary access from Valette Street. The floors offer partitioned studio/offices which have been interior designed with each having good natural light either to the main high street frontage or Valette Street frontage. The units are self contained with kitchen facilities, WC, and shower.

The building is prominently positioned close to the junction with Morning Lane and the Narrow Way a short walk from Hackney Central station. The area is well served by transport links with London Fields station also in walking distance, trains to Liverpool Street (every 15 minutes). Hackney Central provides connections to the Overground network (links to Stratford International and Euston station). There are also several bus routes, 38, 48 & 55 into The City and West End opposite the property and good road links to the A1, A10, A11, A12 & A13.
