LOCATION

DESCRIPTION


The property comprises a building of steel portal frame construction arranged over a single floor offering open plan industrial accommodation with WC facilities. The subjects benefit from 6.8m minimum eaves height, as well as the ability to offer a secure yard (to the front). The subjects have recently been refurbished to a high standard.

ACCOMMODATION
