



# Ground Floor, 22 Nelson Street, Kilmarnock, KA1 1BD

## LOCATION

Kilmarnock is situated in East Ayrshire and serves as the main administrative centre of the council. The town has a resident population of approximately 46,159 persons (Census 2011) although draws on a wider rural catchment population from surrounding towns and villages.

The subject property is prominently situated within the town centre of Kilmarnock and lies to the north-east of Nelson Street between the junctions of Bank Street to the north-west and St Marnock Place to the south-east.
