The subjects comprise a first-floor business centre within a two-storey and attic building of traditional sandstone construction surmounted by a pitched and slated roof while each office benefits from recently installed secondary glazing.

The property is accessed via a secure door entry system on the ground floor, providing access to the common stairwell leading to the first floor.

There are offices of varying sizes available with common access to the recently refurbished kitchen, WC and shower room.

Heating is provided by a newly-installed combination gas boiler, while the electrics have also been recently upgraded.

The property has retained its traditional features, including tall ceiling heights and traditional skirtings and facings.





#### **LOCATION**

Dalry is located approximately 17 miles south-west of Paisley and nine miles north of Irvine. The A739 connects Dalry to Paisley, which in turn gives access to the M8 motorway. The town is well-served by public transport by means of road and rail.

The subject property is located within the centre of Dalry on the east side of New Street between the junctions of Courthill Street and Townend Street.

There is public car parking within the immediate vicinity.
