Description

The subjects form part of a former Mill building, which we understand date from the second half of the 19th century. The buildings are predominantly of traditional stone wall construction under pitched slated roofs.

The accommodation provides mainly cellular office / studio space with communal kitchen and WC facilities. Access is taken from an open courtyard area which is common to the Bowbridge Works estate.

Location

The subjects form part of the Bowbridge Works which is situated on the north side of Thistle Street in the Hilltown area of Dundee.

The property is bounded by Mains Road to the west and the surrounding area is mixed commercial and residential in nature.

The property sits approximately 1.5 miles north of Dundee city centre with good road links to main arterial routes including the Kingsway, Dundee's outer ring road.


