Description

The premises comprise a modern industrial unit of steel portal frame construction, in filled with concrete block and insulated metal sheet cladding to the external walls, under a pitched profiled metal clad roof incorporating translucent perspex panelling.

The accommodation is arranged internally to provide an open plan workshop/store with WC facilities. The workshop area benefits from a minimum eaves height of approximately 5.0 metres and single phase power, with vehicular access provided by an electrically operated roller shutter door.

A secure car parking and yard area is provided to the front.

Location

The property is located on Peasiehill Road, within the well-established Elliot Industrial Estate on the western outskirts of the Angus town of Arbroath, approximately 1.5 miles west of the town centre. Neighbouring occupiers include Halliburton, Tayside Contracts, AGR Automation, Huws Gray and Howden Joinery.

Arbroath is the largest town in the Angus Council area, and has a resident population of approximately 23,000. The town lies on the Angus coast, approximately 16 miles north-east of Dundee and 45 south-west of Aberdeen.
