### **LOCATION**

The property is situated in a prominent location fronting onto Trinity Lane (effectively Hinckley's inner ring road) on the fringe of Hinckley town centre, being opposite a Hammonds Furniture showroom. Blockleys Yard runs down the right hand side of the property which provides access to Regent Court and through to the town centre, approximately 100 yards away.

Hinckley is a market town with a population in the order of 55,000 (Local Authority 112,000) lying approximately 13 miles to the south west of Leicester. The town enjoys good motorway communications with Junction 1 of the M69 Motorway being located on the south eastern fringe of the conurbation approximately 2 miles from the town centre. Hinckley railway station provides regular commuter services to Birmingham New Street and Leicester.

#### DESCRIPTION

The subject property comprises the first floor element of Abbott House, which is three storeys in height. Access to the subject property is via doors to the Blockleys Yard elevation of the property, with stairs up to the first floor. The property benefits from open plan areas with a solid floor and two sets of toilets within the demise. The accommodation is suitable for a variety of purposes (subject to planning).




