## LOCATION

The subject property is located in close proximity to St Catherine's Church in the centre of the village benefiting from free public car parking directly outside of the property. Church Street itself is a mixed commercial and residential area and leads towards the A5 to the south and also via Sapcote Road to Junction 2 of the M69 Motorway.

Hinckley is a market town with a population in the order of 55,000 (Local Authority 112,000) lying approximately 13 miles to the south west of Leicester. The town enjoys good motorway communications with Junction 1 of the M69 Motorway, being located on the south eastern fringe of the conurbation approximately 2 miles from the town centre.

### DESCRIPTION

The subject property is located in the heart of the sought after village of Burbage, with free on street car parking directly in front of the property.

The accommodation briefly comprises: Entrance Hall, Store, male and female WCs, open-plan Office, Kitchen and Boiler Room.

The property may be suitable for alternative uses, subject to planning permission and Landlord consent.


