#### LOCATION

Washingley Road is access from the A141 (Spittals Way) which bypasses Huntingdon to the north and provides access to the A14, together with a direct link to the M11, M6 as well as the A1 and M1. #### **DESCRIPTION**

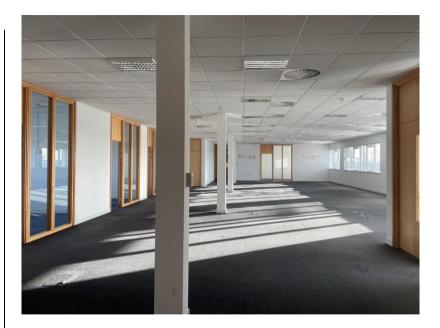
