Bridgwater train station offers railway access between Bristol and Exeter and is circa 1.5 miles to the south of the site.

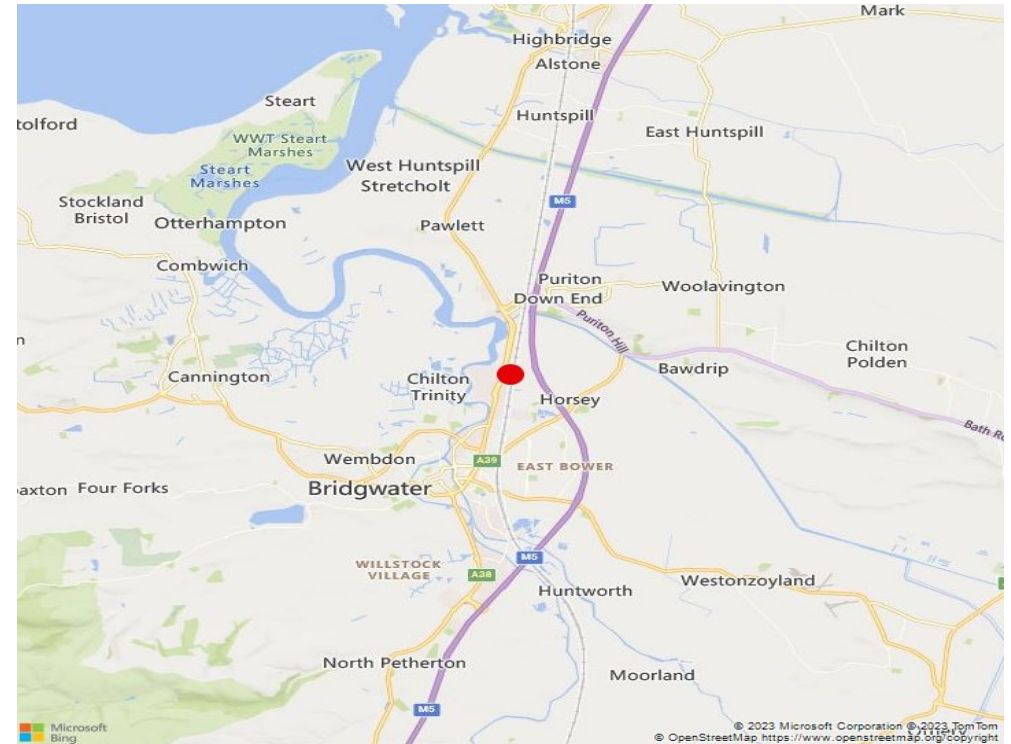
