LOCATION

Avenue Square is the traditional heart of Stewarton Town Centre, located just off High Street and the location of the Town Hall, adjacent to the 'Stewarton Arms' with Ladbrokes on the other side of the property.

Stewarton is located within East Ayrshire around 5 miles north of Kilmarnock, 13 miles south west of Newton Mearns and 20 miles south of Glasgow. The 'Bonnet Toun' has a population of 7,500 persons with an array of new housing being developed.

DESCRIPTION

The 'Stewarton Arms' is a well-established, traditionally built public house within Stewarton Town Centre, occupying a mid-terraced position and contained over two floors with separate ground and first floor access as well as a rear garden enclosure.

The internal accommodation is traditional in style with an open plan main bar and adjacent pool area. There is seating for around 60 patrons. An internal stair accesses the first floor function room, having an independent front door access also. There are toilets on both floors.

The accommodation is as follows:

Ground Floor: Entrance vestibule, main bar, patron's toilets, spirit store, cellar, general store.

First Floor: Function room, patron's toilets, office, studio and general storage.



Stewarton Arms is a well-established pub within Stewarton, widely considered to be one of the town's busier outlets, with reported sales to be in the region of £5,000 - 6,000 per week. There is scope to improve upon past sales levels and perhaps diversify in to food sales, subject to the necessary consents.
