
75 Stanley Street, Kinning Park, Glasgow, G411JH

Stanley Street is located within the Kinning Park area of Glasgow, located immediately south of the River Clyde and 1 mile from Glasgow City Centre.

The subject property is prominently situated with excellent visibility from the M8 motorway; and close proximity to some Glasgow's prime industrial estates including Milnpark Trading Estate and Kinning Parkway. The site provides immediate access into the national motorway network via junctions onto the M8 and M74. Public transport links to the site are excellent with Kinning Park subway station immediately accessible, along with various bus services passing through the area.

Of particular note, the site benefits from close proximity to Scotland's leading trade location in Kingston Trading Estate. Nearby occupiers include Tresspass, Amazon, Edmundson Electrical, Screwfix, Toolstation, Howdens, Speedy Services and Howdens.

Summary

The premises comprise a purpose built substantial detached/stand-alone new build warehouse facility of steel portal construction with insulated profile metal cladding to the walls and roof. Internally the property benefits from 11m eaves and two storey office accommodation. Externally the property has a 1 acre concrete yard and dedicated parking along the side of the building.
