Saltcoats has a resident population of 12,717 persons (Census 2011) and serves as the main retail focus for the towns of Stevenston and Ardrossan. The town has a main line railway station connecting Saltcoats to Largs, Ardrossan, Ayr and Glasgow. Prestwick International Airport is situated approximately 14 miles to the south via the A78 and A77.

Saltcoats is situated on the west coast of Scotland, within North Ayrshire. The subject property is situated to the south of Old Raise Road, west of the junction with High Road.

The surrounding area is of mixed commercial and residential use, with commercial occupiers including Singh is King Hot Food Take Away, Crystal Garden Chinese Take Away, McColls Convenience Store, The Mayfield Café, and Tesco.
