Location

Larbert is located within central Scotland, approximately 31 miles from Edinburgh, 22 miles from Glasgow and 10 miles from Stirling. The M9 motorway links the town to Edinburgh, Stirling and Glasgow via the M876 and M80 motorways. The town has a population of 12,180 residents, and within Falkirk Council area, which has an overall population of 156,800 as of 2022.

Description

Central Park was developed in the 1990's and comprise of 11 modern properties within the business park. Occupiers include, Tilly's Confectionery, Alexander Dennis, Police Scotland, Malcolm Allan, Mathiesons Bakery Haven Enterprises and Springfield Properties.

Site

The area of land is situated within the business park, to the northeast of the Central Boulevard roundabout. The A88 Bellsdyke road is the main road leading to the business park. There are excellent transport links to and from the M876 motorway which provides connections to the M80 and M9 motorways. Larbert train station is located less than one mile from Central Park.


Planning


In planning policy terms, the site lies within a Core Business Area which is covered by Policy JE02 of the Falkirk Local Development Plan 2. This states that:

The core business areas identified on the Proposals Map will be safeguarded primarily for business and industrial use. Class 4, 5 and 6 uses will be supported in principle within these areas.... Other employment uses will be permitted where they will not prejudice the primary business function of the area, are compatible with the business/industrial character of the area and comply with other LDP policies.

"The design of proposals should accord with Policy PE01 (Placemaking) and should include an appropriate scheme of landscaping which integrates any new development successfully into the business park."
