Location

The subject property is located on one of the busiest sections of Perth High Street in Perth City Centre close to its junction with Scott Street and Kinnoull Street.

Nearby occupiers include Costa, Starbucks, Boots, Primark, Holland & Barrett, Sainsbury's Local, Blue Lagoon, Barclays & JoJo Maman Bebe. The main entrance to St John's Shopping Centre also lies adjacent.

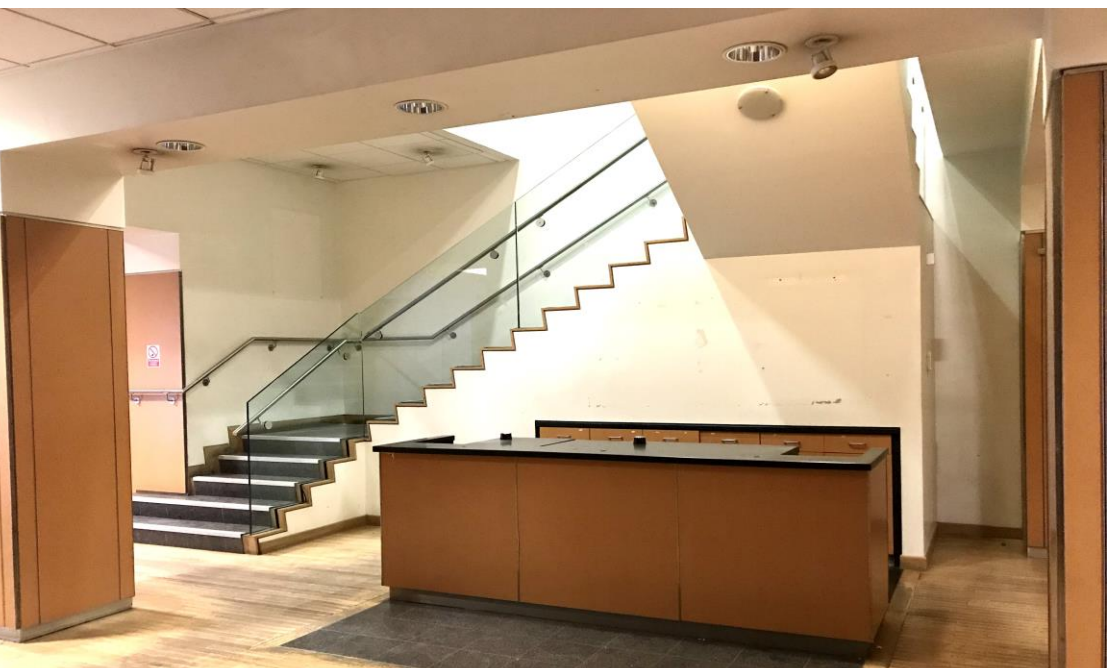
