DESCRIPTION

The site comprises a two-storey building extending to a Gross Internal Area of 7,229 sq ft (671.63 sq m).

Externally there is an area of hardstanding for parking and a hardstanding garden to the rear of the building, and turfed areas to the front and right elevation of the property.

The site extends to an area of 0.27 acres (0.109 hectares).

There are memorials to the front of the property which will need to remain in situ and access will need to be provided.

LOCATION

The site is located on Alwyn Close, New Addington. The surrounding area is typified by residential properties comprising semi-detached and terraced houses, and blocks of flats of around four storeys.

Fieldway Tram Stop is located 0.2 miles from the property, providing services to Croydon. Bus routes also operate within close proximity.

The property lies within the administrative area of the London Borough of Croydon.

PLANNING

We understand the property benefits from Sui Generis – the property had previously been let to The British Legion, where the property was used as a social club and function room for hire. The VOA describe the property as a club and premises.

RATEABLE VALUE

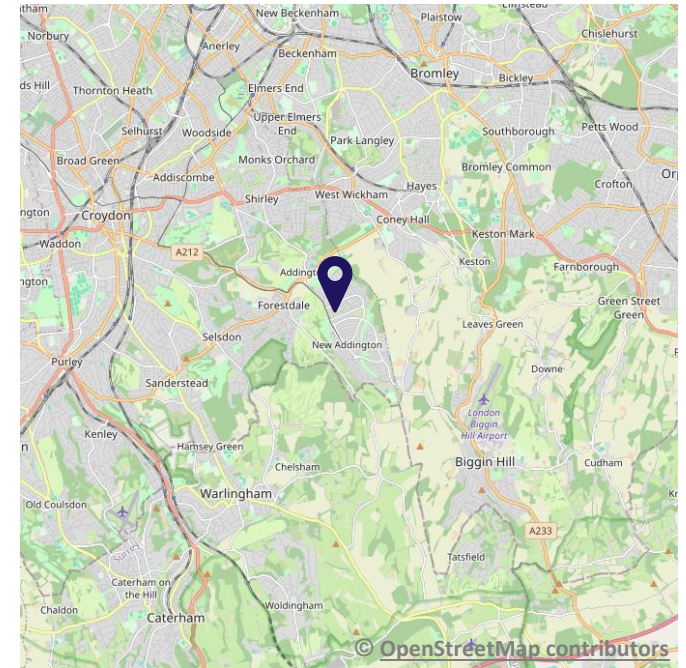

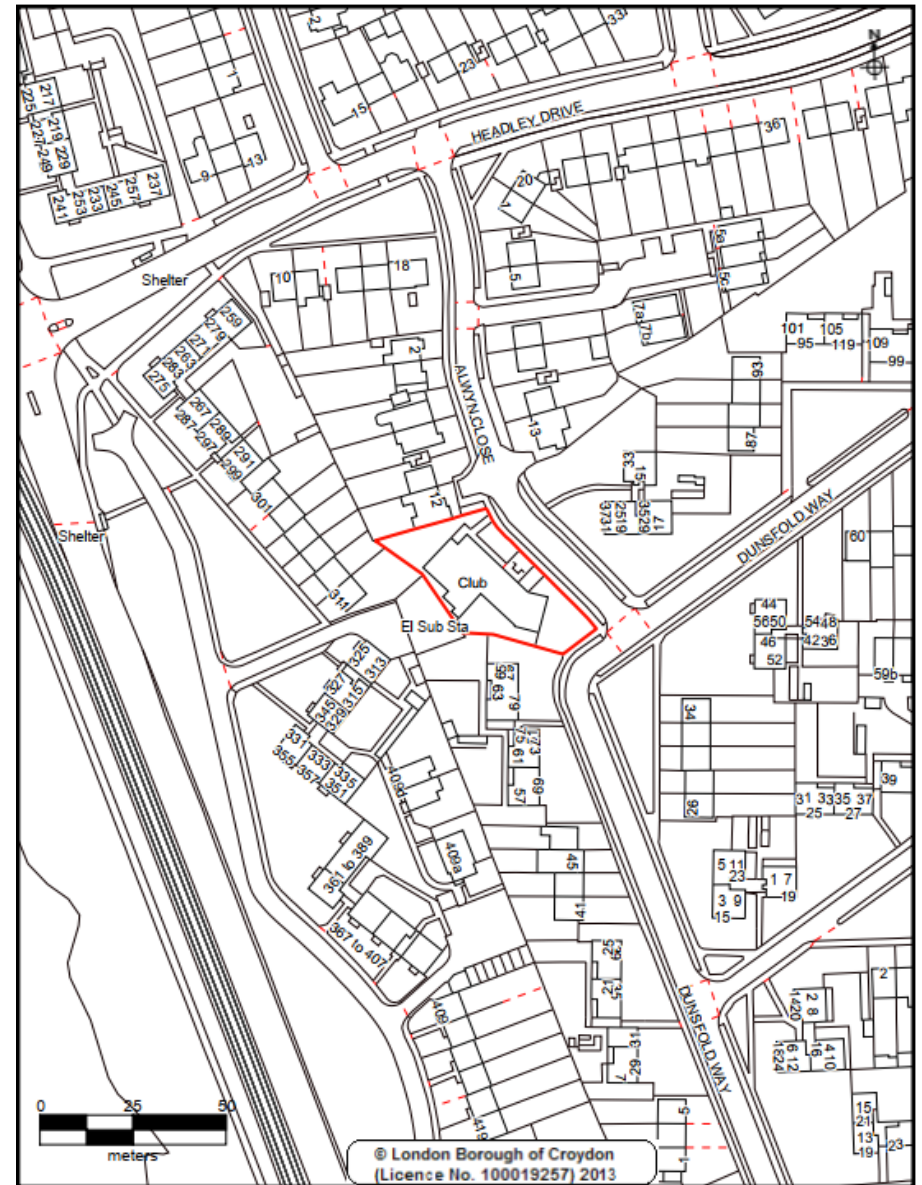
