The property is located in Hailsham, a historic market town in the Wealden district of East Sussex, 10 miles (16 km) north of Eastbourne, 23 miles (37 km) east of Brighton and 18 miles (29 km) west of Hastings. The property is conveniently situated in the surface car park area and forms part of the wider Quintins Shopping Centre, comprising 16 retail units, 180 car park spaces and 28,000 sq ft ASDA. 
