

LOCATION

Frances Industrial Park is one of the most modern industrial locations in Fife and is situated within Dysart on the east side of Kirkcaldy. The estate is well situated to serve all areas of Fife and is within 5 minutes drive of the Redhouse roundabout which links the A92 dual carriageway with Glenrothes and Dunfermline.

DESCRIPTION

Construction of this property in nearing completion and should be ready for occupation in early April 2024. The property has a steel frame design with insulated wall and roof cladding. A full specification of the building together with plans can be provided on request. In general terms the building is of a very similar design and specification to the adjoining properties.

The property will be arranged internally to provide flexible, industrial, manufacturing or storage accommodation and will have a separate pedestrian access door, electric roller shutter door and a 3 phase supply.

SIZE

We estimate the Gross Internal Area of the building to be 325 sq.m (3,500 sq.ft).

TERMS

The property will be available on a full repairing and insuring basis and a rent equating to £7.50 per sq.ft. (£26,250 per annum) exclusive of VAT. The lease term is to be agreed.
