
#### Introduction


North Lanarkshire Council (NLC) offers to the market an excellent development opportunity.

The Council will only accept bid submissions made via the Public Contracts Scotland portal. Bids arriving after the closing date/time will not be considered nor will bids sent by fax or email.

### **Following Closing Date**

Developers' proposals will be utilised to identify a short list of interest, and further technical information will be released to inform a second and final proposal. It is anticipated that developer interviews will be held in consultation with relevant council departments such as Roads, Planning and Housing prior to selection of a preferred purchaser.

Final authority to proceed with the disposal will be required from NLC's Finance & Resources committee, the date of which will be the first hearing following selection of a preferred purchaser. The final legal offer production will be by agreement between the council and the preferred bidder.
