Location

The business park is well located close to Perth Town Centre in an established retail and commercial area behind St. Catherine's Retail and Leisure Parks which is anchored by The Range, Sports Direct, Halfords, T K Maxx, PC World and Home Bargains. The Glasgow Road and Dunkeld Road are close-by and being part of Perth's main arterial routes provide easy access to the wider motorway network.

Description

Ladeside Business Centre comprises 17 industrial units ranging in size. Units 2 & 3 are the only available units at present. Unit 3 comprises a flexible use unit that has a mix of office, reception and studio/storage accommodation. There is also a small mezzanine above the office accommodation. It has been fitted out with energy efficient infrared wall mounted heaters throughout. Unit 2 is more open plan with a metal mezzanine providing approx. 500 sq ft of additional useable space.


