

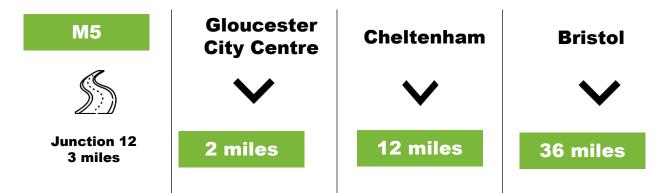
Location

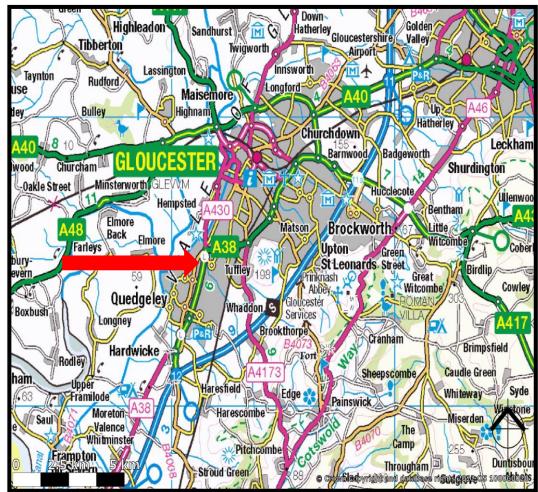
Building 2 Olympus Park Business Centre comprises a detachedd two storey office set in mature landscaped grounds.

Olympus Park is located close to the major road intersection where the A38 joins the Gloucester Ring Road, the South West Bypass and the A430 Bristol Road.

Gloucester City centre is approximately 2 miles north and Junction 12 of the M5 Motorway is approximately 3 miles south.

Building 2 comprises an attractive two storey detached office building of brick elevations under a pitched tiled roof.

The building currently provides a mix of open plan office space fitted to a high standard with a number of partitioned rooms.

Male, female and accessible WCs are provided with the service core together with a passenger lift. The accommodation is fitted with suspended ceilings and recessed lighting, carpeting and has 28 car parking spaces.
