Location

Shakespeare Business Centre is located off Shakespeare Road near its junction with the (A335) Twyford Road and within close proximity of Eastleigh Town Centre.

Communication links are excellent. Access to the M3 is via Junctions 12 & 13 both within approximately 1½ miles and the M27 can be accessed at Junction 5 within approximately 2 miles via Southampton Road. Southampton Airport is also within 2 miles. Eastleigh train station is approximately 1/3 mile to the south.

Description

The property comprises an end of terrace two storey business unit of brick and block construction under a pitched steel clad roof.

The original ground floor workshop has been partitioned to include a large boardroom, filing room/office and store. Loading is via a manually operated sectional up and over door measuring approximately 2.70m high by 3.00m wide. Stairs lead to the first floor offices which are predominantly open plan. The unit benefits from the following features;

- Suspended ceiling with LED lighting
- Gas central heating
- Carpet
- Category 5 cabling
- Perimeter trunking
- Air conditioning to first floor
- Kitchen facilities to both floors
- Male and female cloakrooms

Three phase electricity, gas and telecom are connected.
