### Description

The property comprises of a factory with brick elevations under a pitched roof. A roller shutter door measuring  $3.04 \,\mathrm{m} \times 3.06 \,\mathrm{m}$  provides access to the unit, which incorporates a solid floor and lighting throughout. There is also a three phase power supply. The unit has a minimum eaves height of  $4.08 \,\mathrm{m}$ .

The property is located approximately two miles south of Chiddingfold in a rural setting. The A283 Petworth Road from Chiddinfold connects with the A3 at Milford, approximately five miles to the north. Other nearby towns include Haslemere (5 miles), Billingshurst (10 miles) and Guildford (11 miles). Rail services are available from Witley Sation which is approximately two miles north of the Village.


