Description

Unit 2, 7 Station Road is a practical industrial warehouse unit suitable for storage and distribution purposes. The property is of steel portal frame construction with brick elevations and comprises LED strip lighting internally, a concrete floor, double glazed windows, a roller shutter loading door measuring (2.39m h x 2.15m w) and three phase power supply. The service road to the unit offers unallocated parking for the property.

The property is suitable mainly for warehouse uses, however other uses are welcomed, subject to planning permission where required, and landlord approval.

Location

The property is located in Tidworth, with good access to London and the West Country via the A303 and M3. Tidworth is a small garrison town in Wiltshire, located in close proximity to the Salisbury Plains. With a population of 12,000 Tidworth has seen growth in recent years due to the military barracks being located in the town.

The nearest railway station is in Andover, located approximately 9 miles from the subject property.


