## Description

Unit 6 comprises a mid terrace light industrial/warehouse unit on the ground floor with offices at first floor level.

The premises have been built to a high specification and benefit from excellent access/loading and car parking. The fitted offices have CAT 2 lighting, gas fired central heating and perimeter trunking. The building also benefits from an entry phone system and 4 car parking spaces.

## Location

Trade City, Brooklands, Weybridge is situated on Avro Way on the established Brooklands Industrial Estate. The estate is located off the A3 (approximately 3 miles) which provides direct access to Central London and Junction 10 of the M25.

Byfleet and New Haw mainline railway station is within half a mile of the scheme with a journey time of 40 minutes to London Waterloo.

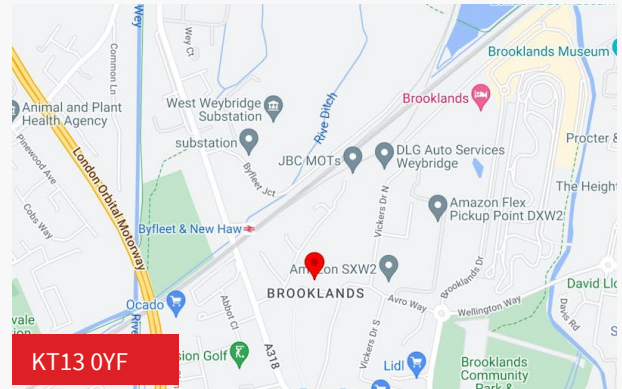
