Suites of varying sizes on the first and second floor available for immediate occupation.







LOCATION

The property is located on Home Park Industrial Estate on Station Road in Kings Langley which is within 25 miles of the North West of London. Kings Langley High Street is just 0.5 miles away. Watford is only four miles away and Hemel Hempstead within three miles.

Junction 20 of the M25 motorway is within 0.5 miles and Junction 8 of the M1 is within five miles. Kings Langley railway station is a two-minute walk from the property and gives fast regular access to London Euston.

KINGS LANGLEY

The commuter village of Kings Langley sits on the River Gade and The Grand Union Canal just 21 miles north-west of the heart of London, two miles south of Hemel Hempstead and two miles north of Watford.

The village pubs, such as The Rose & Crown and The Unicorn, serve excellent food and drink, as do the local restaurants and cafés, Oscars Pizza Co., Dalling and Co., and Fred and Ginger Coffee.

The peaceful surroundings provide excellent opportunities for waterside walks, cycle rides and boat trips. Kings Langley High Street is a short walk away from the property and there is a range of places to stay including a Premier Inn.

The village benefits from good road communications. The M25 is just a two minute drive away and the M1 is six minutes away for journeys south and also destinations further north, such as Luton and Milton Keynes.

Kings Langley railway station is a two-minute walk away from Concept House and provides half-hourly services direct to London Euston in the south and Tring in the north. Rush hour services run towards Birmingham New Street and Coventry, whilst a single service to Crewe also runs every morning.


