#### LOCATION

The property is located between Stocks Street East and Red Bank in Cheetham Hill, Manchester. Manchester City Centre is approx. 0.5 mile to the south. Manchester Victoria Railway Station and Metrolink Station are around 500m to the south. All city centre amenities are easily accessible. Cheetham Hill Road (A665) is within close proximity and provides easy access to Junction 9 of the M60 motorway approx. 3.5 miles to the north.

#### DESCRIPTION

The unit comprises a warehouse of steel portal frame construction with brick elevations beneath a pitched steel sheet roof. There are offices at lower ground level to the rear of the property. There are yard areas/parking to the front and rear of the unit.

Internally, the unit has mainly open plan warehouse space but with a kitchen/staffroom, WC facilities and a mezzanine storage area. There is roller shutter loading door access and the unit has an eaves height of 3.1m.


