LOCATION

The property is located on the north side of High Street (A6) close to its junction with Bolton Road (A575) in Walkden Town Centre. The property is within close proximity to Walkden Shopping Precinct and includes a large range of shops and places to eat. Walkden Train station is approximately 0.5 mile south east of the subject property. Junction 14 of the M60 motorway is approximately 1 mile south east. Walkden is situated 7 miles north west of Manchester City Centre.

DESCRIPTION

The property comprises refurbished office space within Worsley Court – a purpose built office premises of brick construction beneath a pitched slate roof. The accommodation is arranged over ground, first and second floors and benefits from the following:-


