The property is located on Baltic Street West, approximately 50 metres from the junction of Clerkenwell Road, Goswell Road, Old Street. Transport links for the property are excellent, with various bus routes running along Goswell Road and Old Street. Barbican and Farringdon (Circle, Hammersmith & City, Metropolitan, National Rail and Crossrail Lines) as well as Old Street (Northern and National Rail Lines) Stations approximately 250 metres, 600 metres and 1,000 metres away from the property respectively. The local area benefits from a wealth of amenities including various bars, restaurants, shops and eateries and it is located only a short distance from Whitecross Street. Whitecross Street has a food market Monday to Friday offering a variety of world cuisine.
