

LOCATION

The subjects lie to the south of Rumblingwell, the main arterial road on the north western outskirts of Dunfermline. Surrounding properties are a mix of commercial and residential. All services are readily available and the property is within easy walking distance of Dunfermline town centre. The former Dunfermline to Alloa rail route lying to the south of the site has been converted into a cycle track with ancillary landscaping.

A copy of an OS Extract and Location Plan are shown overleaf which highlights location of the subjects.

Dunfermline itself lies in West Central Fife with resident population of approximately 58,000.

DESCRIPTION

The subjects comprise an open site extending to approximately 2.361 acres/9,553.7m² or thereby. The site is currently used for a mixture of car sales and caravan storage.

We understand that services are available to site perimeters, although this would require to be checked by potential purchasers.

PLANNING

Planning Permission was granted in 2008 with Outline Planning Consent for the creation of 24 flats and a plot layout for 14 residential plots with associated access road, car parking, open amenity space, play area and boundary treatment.


