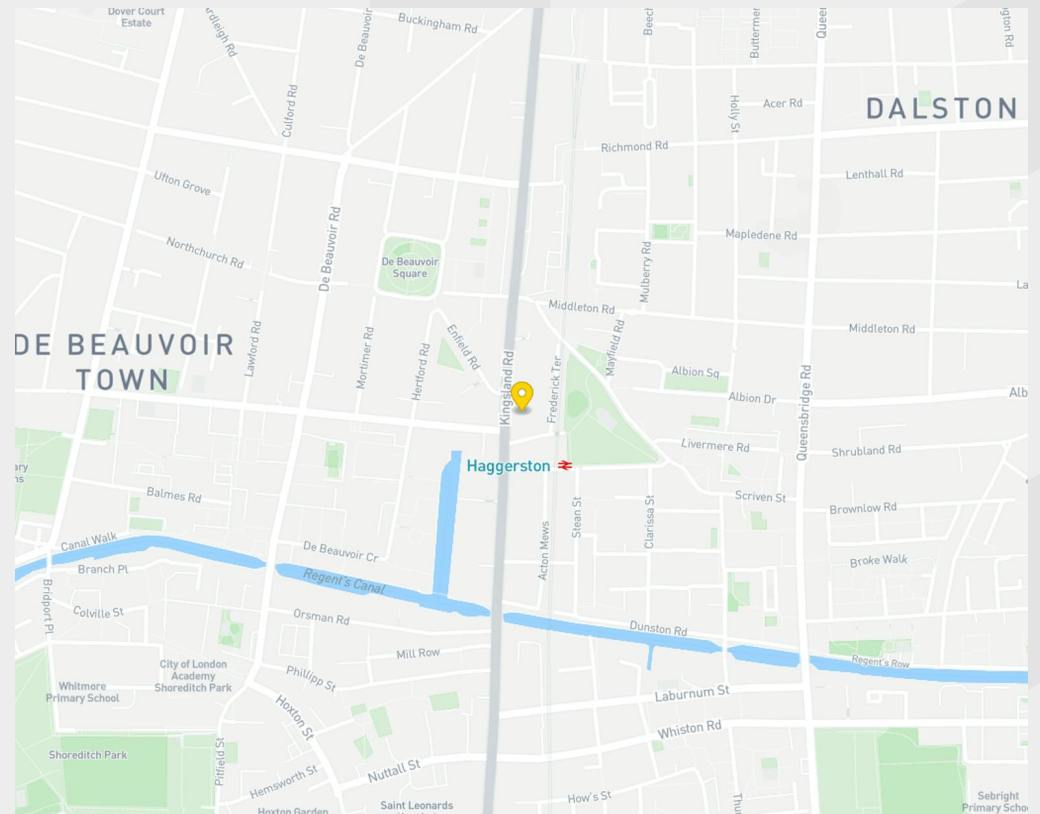


Description
